
- Space agency of the Netherlands government (established 2009)

About G4AW



- Aim:
 - to increase the agricultural sector output by providing food producers (> 3 million) with relevant information, advices or (financial) products through operational information chains using satellite data.
- Outcome:
 - improved sustainable food production, more effective use of inputs (water, nutrients), and economic development (>10%)
 - stimulating private investments
 - leading to financially sustainable services

Evaluation 1st call for proposals (sector)

Evaluation	Implementation
Number of users too high	Adopted (lowered)
Time frame (3yr) too short	Adopted (one year extension possible)
Minimum subsidy (\in 1M) too high	Adopted (lowered)
"existing partnership and/or business cooperation as basis for G4AW project"	No, is included in assessment
"large investment by partnership"	No, is included in assessment
% subsidy country in transition too low	Adopted (from 40% to 60%)

Evaluation 1st call for proposals (sector)

Evaluation	Implementation
Financial rules (salary) unfavorable, results in larger investments when having larger overhead cost	No, methodology used is fair basis for all countries and is also used by other RVO and MFA programmes
Cost for acquisition are considered to be high	Acquisition cost are not subsidizable, request-for-advice proposal has been shortened
Capacity to invest by Dutch partners as applicant in acquisition and cost might be too low	Adopted (applicant may come from any country, one Dutch organization as partner)
Increase number of partner countries	Adopted (neighbouring cuntries added, 26 in total)

Evaluation 1st call for proposals (sector)

Evaluation	Implementation
Request for Advice procedure was highly appreciated	To be maintained
Less stringent rules for partnership	Simplified (composition, agreement)
Less stringent rules for own investment	Simplified
Less stringent rules for CSR implementation	Not needed for public organisation, for private organisation remains as is
Synergy with other governmental programmes	Possible, but there is a policy rule on MFA funding

Policy rules I

Policy rule	Treshold criterium
Number of users	100 000 farmers or 50 000 agro-pastoralists or 50 000 fishermen
Project duration	3 year (+ 1 year extension budget neutral if needed)
Minimum grant	€ 500 000
Maximum grant	€ 5 000 000
Partnership	Minimum: One organisation from G4AW partner country + 1 organisation from Netherlands Minimum: one public, one private organisation Applicant: all countries eligible





Policy rules II

Policy rule	Treshold criterium
Own investment partner country (23 countries)	≥ 30%
Own investment partner country in transition (3 countries)	≥ 40%
Partnership agreement	Obligatory, waiver for a governmental organisation via a Letter of Intent or Memorandum of Understanding
CSR policy	Obligatory for private organisations, must be developed in 1st year of project if not existing yet (template available)





Project assessment (March-July 2015)

Criteria (quality)	Maximum score
Partnership	75
Business proposition	125
Project	110
Information chain	60
Bonus (for 13 countries)	10 per country (up to 30 max.)
Total	400 (max.)




